### GENERAL ORDERS #6 DECEMBER 2025

General Orders are to be read at each Post Meeting and placed on file.

- 1) The Next Council of Administration meeting will be held at the Concord VFW Post 1631 January 17, 2026.
- 2) VOD Banquet will be held at the new Concord DoubleTree (the old Holiday Inn) More to follow.
- 3) Attention of Post Commanders is directed to Section 218(a)(11)(b), Manual of Procedure, Trustees, which states that Post Trustees shall prepare and submit quarterly, through their Post Commander, a Post Trustees' Report of Audit to the Department Quartermaster for referral to the Department Inspector.
- 4) Change of Post and District Officers: All District and Post Commanders are reminded that whenever there is change of Officer(s) within the Post or District that they need to **FILE A NEW ELECTION REPORT** and notify the State Adjutant Office ASAP so that the Department directory can be updated accordingly, and the information disseminated to all in the General Orders.
- 5) All officers should obtain current 2026 copies of the podium edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual. Copies of the revised edition of the Congressional Charter, Bylaws, Manual of Procedure and Ritual are available through the VFW Store at National Headquarters. The 2026 revised edition reflects the amendments adopted by the 126th National Convention. Digital version is downloadable from OMS.
- 6) Convention Book Advertising: Consult Tele-Communications from Londonderry, NH is soliciting ads for our State Convention book throughout the State of Maine. Any business calling your Post respectively, inquiring about the solicitation, please inform them that they are the sole company that sells ads for the Department of New Hampshire.
- 7) Post Commanders: Sections 219 and 704 of the Manual of Procedure outline the various things for which the Post Relief Fund can be used. Several years ago, the phrase "To foster true patriotism through historical and education programs," was added to this section. This allows the Post to use the relief funds for the Voice of Democracy program or other Americanism programs that are educational. This does not include Post building projects, hall remodeling, color guard uniforms or any other expenditure that does not follow these guidelines.

## Department of New Hampshire National Legislative Committee Member Monthly Legislative Report December 2025



I want to tell you about a phenomenal documentary I recently watched on Netflix.

Seen "In Waves and War" on Netflix yet? What an incredible documentary! This is "nested" perfectly with one of the VFW's Legislative Priorities; Health - Research the efficacy of plant-based alternative therapies for PTSD.

Here is the synopsis - "*In Waves and War* focuses on a group of U.S. Navy SEALs who take Ibogaine, derived from a shrub native to Central Africa called *Tabernanthe iboga*. It's illegal in the U.S., so these veterans have traveled to a clinic in Mexico, and researchers studying Ibogaine at Stanford are following their progress."

The VFW has been a leader in the Veteran's community and supports many types of alternative therapies.

#### VFW-Affiliated & VA-Supported Alternative Therapies

The VFW has highlighted specific programs and the VA health system has integrated several complementary and alternative medicine (CAM) approaches:

1. **Guitars for Vets:** The VFW National Home highlights this program, which offers an alternative to traditional talk therapy by using music as a way to help veterans cope with depression and PTSD symptoms. Participants receive free guitars upon completion of the program.
2. **Acupuncture:** Used in the VA system, acupuncture shows promise in modulating the nervous system, improving sleep quality, and managing chronic pain, which are often co-occurring conditions with PTSD.
3. **Yoga & Tai Chi:** These mind-body practices are often used to address the physical and emotional symptoms of PTSD. Yoga can improve emotion regulation and decrease physiological arousal, while Tai Chi has been associated with fewer intrusive thoughts and better concentration.
4. **Art Therapy:** The VA uses art therapy, which provides a non-verbal outlet to process trauma and emotions that may be difficult to vocalize, helping to organize and integrate traumatic memories.
5. **Mindfulness & Meditation:** Mindfulness-based interventions are used to develop present-centered awareness and nonjudgmental acceptance, which can help veterans manage hyperarousal and reduce avoidance behaviors.
6. **Exercise and Nutrition:** Regular physical activity and a healthy diet can help manage common comorbid conditions such as pain, obesity, anxiety, and depression, which often accompany PTSD. These methods offer options for veterans who may be unwilling to engage with traditional talk therapy or are seeking a more comprehensive approach to managing their symptoms.

- By obtaining a raffle ticket, you attest that you are a law-abiding citizen of good moral character, may legally possess the gun(s) won, have intention of using the gun(s) won only in a legal and safe manner and will obtain or have already obtained instructions on the safe use and operation of the gun(s) won.
- One gun will be raffled each day beginning January 2<sup>nd</sup>, 2026, and continuing for 30 days thereafter.
