General Orders are to be read at each Post Meeting and placed on file.

COMMANDER RIDEOUT HAS ISSUED A CHALLENGE, ANY POST THAT REACHES 100% OR MORE IN MEMBERSHIP BY MARCH 17TH WILL BE ELIGIBLE TO ENTER INTO A RAFFLE FOR \$200.00 OF THE COMMANDER'S MONEY

- 1) The Next Council Meeting will be April 29th at the Concord Post (Auxiliary) 9am, and the VFW will be at the NH National Guard Heritage Room. Finance Committee 9am, VSO Meeting 930, COA 10am. This is a change to the published schedule.
- 2) Joint Testimonial for State Commander Rideout and State President Dot Mattson will be held at the Concord Holiday Inn on April 29, 2023. <u>This is a change to the published</u> schedule.
- 3) <u>LOVE GIFTS FOR COMMANDER AND THE PRESIDENT'S TESTIMONIAL</u> For the State President gifts should be sent to Department Sr Vice President Kim Copson 8 North Ave. Apt A. Derry NH 03038 and for the Department Commander gifts should be sent to Senior Vice Commander Denis Querrard, 30 Laurel St, Whitefield NH 03598.
- 4) <u>Attorney Charitable Trust Registration exemption</u>: Not ALL VFWs are exempt. They have to file the pre-registration review form (even if registered). They will review it and respond accordingly. The Post will receive a letter either approving or denying. I have attached the form.
- 5) Attention is directed to Section 217 of the National Bylaws and the Manual of Procedure covering the nomination, election and installation of Post Officers. Nominations are to happen at the March Meetings and remain open until the April meetings. Post Election Report forms are being mailed to Post Quartermasters with instructions that they complete the form online through the Online Membership System (OMS) or they can complete the form and return directly to National Headquarters immediately following the election of Post Officers but not later than June 1.
- 6) Section 222 of the National Bylaws and the Manual of Procedure provides that delegates and alternates for the District Convention and meetings, Department and National Conventions shall be elected at a regular meeting in April. Posts are entitled to one (1) delegate and one (1) alternate for each thirty (30) members or fraction thereof in good standing in the Post as of March 31.

I do want to thank members of the Department for the efforts put into building the Membership in the Department of NH. As years go by, we witness the total members numbers falling to new lows. This year we have the opportunity to gain in number. I am Not big on numbers for examining our well being but I am going to share some numbers that have jumped out to me today. Having talked with most Post Commanders or QM about their membership recruiting I find that in most Post, membership is entirely on the Post Quartermaster. This needs to be revisited at ALL Post meetings. Every member needs to feel part of the membership team. In most Post meetings that I have visited, often I don't even hear the word Membership. So !!!!

Department now has 10 Post that are at 100% or more, Congratulations! Twenty-Two (22), need less than Ten (10) and of those 22, we have (15) which need less than (5). Sadly Eight (8) Post need more than 10. Two of those Post, needing (20) or more, I have had no response from Post Commanders nor QM. Closing out on these numbers I will say we need 268 members as of today for 100%, if every Post should make 100% we will have only 249, hoping that of the 51 at Large will put us over the needed members. We can do better my friends. We need to for the sake of our Veterans and their families. They need our help in Washington as we know.

With election season upon us it may be the right time for members to get officers in place that want to work for the good of their Post, and their communities. Going to CofA's and District Meetings it's apparent some are not performing.

We are members of the greatest Combat Veterans in the world and it's hard to believe we have hundreds of prospective members in this state that have Never been asked to join the VFW. With nice weather in the bloom we need to be discussing recruiting at our monthly meetings. You need not be an Officer to get a list of your unpaid or even reinstated list. If needed, please contact Department of NH Adjutant Paul Lloyd and I am sure he will work with you.

Let's get out and plant those membership seeds.
