GENERAL ORDERS #3 SEPTEMBER 2022

General Orders are to be read at each Post Meeting and placed on file

1) Every Post chartered by the Veterans of Foreign Wars of the United States will be expected to participate in the following programs during the 2022-23 year: Voice of Democracy, Patriots Pen, "Buddy" ® Poppy and Veterans and Military Support Programs. Additionally, it is necessary that all Post and Department Commanders comply with all provisions of the National Bylaws and the Manual of Procedure and Ritual.

2) Patriot Day, September 11: Per Presidential Proclamation, September 11, is designated as "Patriot Day." The President requests the flag of the United States to be flown at half-staff (sunrise to sunset) and a moment of silence observed in honor of the individuals who lost their lives on that day due to terrorist attacks on the United States.

3) ONLINE REPORTING: For Online Reporting, go to <u>https://nh.vfwportal.net/public/,</u> your sign on is your Post number and your password is abc123 all lower case, it will never change. Example: Sign On: 3041 Password: abc123

4) **REQUEST FOR DEPARTMENT REPRESENTATIVE:** Request for a Department Representative for a special event, must be submitted in writing to the Department Adjutant, PO Box 955, Concord, NH 03302-0955 or e-mail: <u>nhvfwstateheadquarters@gmail.com</u>

5) POST COMMANDERS: Are reminded that Section 203 – Regular Meetings – All Posts shall hold at least one regular meeting each month. Failure to comply can result in immediate revocation of the Post Charter notwithstanding the provisions of Section 211 of the Manual of Procedures.

6) OFFICERS DUTIES: Article II, Section 218 – Officers and Chairman, Duties and Obligations -(a) Officers – (1) Duties of Commander - item (k) – "Assure that the Commander or their representative attend all properly called District conventions or meetings." Post Commander must attend District meetings. Failure without just cause to perform these duties may result in removal from office. All Post Senior and Junior Vice Commanders are urged to attend all District meetings planned. The Post Commanders should employ all elected Post Officers and post members to attend District meeting

7) DISTRICT MEETINGS DATE CHANGES: District Commanders are reminded to notify the State Adjutant office ASAP of any changes in District meeting dates so that the respective Department Representative can be notified in plenty of time.

8) Post Inspections: Section 518 provides that the Department Inspector shall require that each Post be inspected in accordance with Department and National guidelines. The purposes of the inspection is to assure that the Post operates in a manner that supports the purposes set forth in the Congressional Charter, complies with the By-Laws, preserves the financial integrity of the Post and protects the interest of the member. Every Post is expected to be inspected at least once each year. It is the duty of the District Inspector to notify the Post Commander, Quartermaster, Adjutant and Trustees of the date and time that the inspection is scheduled. The inspector should allow you enough time to prepare for the visit. The Post inspection will go a lot smoother if it is conducted at some time other than a Post meeting night. If, for any reason, a Post cannot be inspected thoroughly, a report stating the facts must be submitted. It is the responsibility of the Post Quartermaster and Post Adjutant to provide the records necessary to complete the duties of Inspector. When the inspection of a Post is completed, the Post Inspection Form will be made out in triplicate. The yellow copy will be mailed to the Post Commander and a copy should be retained for your files.

National POW/MIA Recognition Day is observed on the third Friday in September. It honors those who were prisoners of war (POWs) and those who are still missing in action (MIA). It is most associated with those who were POWs during the Vietnam War. National Vietnam War Veterans Day is March 29, the date in 1973 when the last US combat troops departed the Republic of Vietnam. This day was established by an Act of Congress, by the passage of Section 1082 of the 1998 Defense Authorization Act. It is one of six days that the POW/MIA Flag can be flown. The POW/MIA flag was first recognized by Pub.L. 101–355 and made into 36 U.S.C. § 189 in 1990.

Department Quartermaster Comments

Greetings Comrades,

On the business side.

Trustee reports, the regular culprits are behind, and their District Commanders have it on their plate to assist them in getting them turned in. To the Posts that are on time and legible, thank you. I can send out the electric form if anyone wants it, either form is acceptable, but I admit if they were all the same it would streamline things. As part of our efforts to improve operations the Trustee reports will be forwarded to the Department Inspector for review, so Commanders you may have questions from him at some point. Also, the Inspector and I agree if you cannot get all the signatures on time, send me a copy to work with and follow on when you have all the signatures. This does not mean you are off the hook of getting all your Trustees to review your books, just a way to keep things moving.

Quartermaster Bonds, the vast majority have been turned in and we are working with the remaining handful. Couple points, you are not required to Bond the Commander or any officer other than the Quartermaster. You can if you want but it should only be an officer dealing with your funds. Also, it is easier to overestimate the amount you need then to increase it later. The amount you have is an item that you should track and make sure your bond covers it.

Canteen Manager/Employee Bonds, these forms and amounts are different than the QM Bonds. I was advised to wait till the end of August to send that information out to prevent confusion with the QM bonds. I do not think we prevented anything and the Posts that got ahead of the curve and already sent in paperwork for Canteen Managers I will work with. Next year we will try sending everything out at the same time and see how that works.

On a good note, Nancy who works with John Barret in our Service Office recently got married, congratulate her if you stop in.

The Department did send \$1,000 to the Department of Kentucky to help our comrades down there deal with the recent flooding. Sometimes nature strikes and VFW Posts can become a center for the community to operate out of. Helping our fellow Veterans is why we are here.

Your high priced lawyer will have the same results, except you get to pay him for his time that he spent telling you that he's working hard for you as he's waiting for the VA to respond.

Greetings comrades from the confines of lake Winnipesaukee. September is suicide prevention awareness month. Suicide is a problem that touches the lives of many Americans. Some of us may know someone, such as a fellow Veteran, coworker, or family member who has attempted or died by suicide.

WARNING SIGNS of SUICIDE

- ★ Frequently talking about self-harming or portraying themselves in a negative way
- ★ Feeling hopeless
- ★ Loss of interest in activities that once brought joy
- ★ Withdrawal from friends and activities, increased alcohol/drug use, difficulties in sleeping or eating, decreased self-care.
- ★ Preparing for death, such as preparing/updating a will, giving away possessions, or taking steps to access lethal means, such as purchasing a firearm/weapon.

Starting July 16, 2022 the new suicide crises line has been established, the number is **988**.
